After obtain the affiliation from C.B.S.E., New Delhi, the Management of the school will be bind to provide the salary and other allowances to the School Teaching Staff and Non-Teaching Staff as Government Employees and the No Objection Certificate will be withdrawn in the event of non performance of the same.

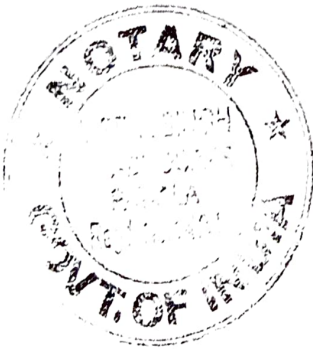
